

Environment and Food Foundation (E2F) was fully represented at the IUCN Africa Protected Areas Congress (APAC) by our founder and chief of operations and they were also delegates of Wild Foundation.

Introduction;

The Africa Protected Areas Congress (APAC) was held in Kigali, Rwanda from July 18-23, 2022. The congress was co-organized by the International Union for Conservation of Nature (IUCN) World Commission on Protected Areas (WCPA), the government of Rwanda, and the African Wildlife Foundation.

APAC brought together over 2,300 physical participants and 100 virtual participants, representing government agencies, NGOs, Indigenous peoples, youth, academia, and the private sector. As the first ever protected areas conference of this scale in Africa, there was significant momentum around positioning Africa's protected and conserved areas within the broader goals of economic development and community well-being.

Background/introduction to IUCN-APAC.

The African continent alone holds up to 30% of the World's biological diversity, yet home to the World's fastest growing population- with an estimated size to hit about ... by 2050.

The richness in the continent's biodiversity straddle across from the varsity of landscapes, cultures and traditions, species of flora and fauna – that have long been pivotal towards contributing towards the socio-economic development of the nation's therein.

The inaugural IUCN-APAC, first of its kind steps in at a time when the continent and World at large are faced with the twin crises biodiversity loss and climate change putting Africa even more vulnerable to the adverse impacts of these twin crises.

Relevance of IUCN-APAC towards the African Conservation Agenda

With a size of over 30.37 million sqkm, only about 7% of this total land mass comprises protected and conserved areas. The African continent alone has up to 3,000 total protected and conserved areas stretched across the continental space. With this, it is only paramount that these critical habitats are safeguarded and conserved for future generations.

Whereas there have been ongoing efforts to conserve and protect these landscapes, flora and fauna, these have still not yielded the desired results in ensuring the continent's natural heritage and biological diversity are well protected and conserved.

The COVID-19 pandemic additionally came through with a swing- disrupting both global health and economies, yet the African continent has not been exempted from the adverse effects of the pandemic.

A development paradigm that acknowledges the critical role of protection and conservation of biodiversity is vital towards driving the ambition we need for a sustainable future in Africa.






2. Presentation; Youths and IPLC: Critical insights on their role for the conservation of environment, case of Douala in Cameroon.

Better understanding of the need for youths and IPLC in nature conservation. The congress was an eye opener for my future engagements in biodiversity and conservation "Once I was blind now I can see". How to sustain a nonprofit organisation to thrive for centuries.	To achieve the set goals of 30*30, all stakeholders- governments, IPLCs, youth and civil society groups must act immediately. However, protecting only 30% will not be enough if we intend to achieve the set minimum 30*30 goal- we ought to set the bar higher by advocating to protect up to half of the planet in order to as well achieve the goal of living in harmony with nature by 2050.
	The biodiversity and climate crises are directly linked and interconnected- thus should be treated as whole- further recognising the role of nature/ protected areas in addressing the climate crisis. Africa has a full potential of sustainable development; however, we need to strengthen collaboration among the various actors to act for nature now!

Outcomes; (Short and long-term) in relation to the Congress outcomes (Kigali call to Action):

Recommendations and calls to action:

Conservation of at least 30% of Africa Protected Areas by 2030 (30*30 agenda).



Conservation of an average of 50% of Africa Protected Areas as soon as possible (#natureneedshalf) while taking into consideration the respect of indigenous people rights to lands, equitable governance and co management.

Build the capacities and strengthen youth to be changemakers, leading conservation action in their own communities.

Recognise the need to enhance dialogues on nature within upcoming climate discussions and spaces- while acknowledging its role in promoting the same.
